## SUNAPEE, NH RENEWAL FRANCHISE

## INTRODUCTION

WHEREAS, Comcast of Connecticut/Georgia/Massachusetts/New Hampshire/New York/North Carolina/Virginia/Vermont, LLC (hereinafter "Comcast" or "Grantee" or "The Company") is the duly authorized holder of a Franchise to operate a cable television system in the Town of Sunapee, New Hampshire (hereinafter the "Town" or "Grantor" or "Franchising Authority") pursuant to NH R.S.A. 53-C, as amended, said Franchise having originally commenced on December 6, 1991 between Grantee and Westmarc Development Joint Venture d/b/a Twin Valley Cable TV; and

WHEREAS; Westmarc Development Joint Venture transferred the Franchise to FrontierVision Operating Partners, LP, l/k/a Adelphia Communications on December 2, 1997 which was subsequently transferred to Comcast on July 31, 2006; and

WHEREAS, prior to the transfer, Adelphia filed a request for renewal of its Franchise on February 13, 2004, in conformity with the Cable Communications Policy Act of 1984, as amended (the "Cable Act"); and

WHEREAS, there has been an opportunity for public comment, as required by Section 626(h) of the Cable Act; and

WHEREAS, the Franchising Authority has determined that the financial, legal, and technical ability of Grantee is reasonably sufficient to provide services, facilities, and equipment necessary to meet the future cable-related needs of the community, and desires to enter into this Renewal Franchise with the Grantee for the construction and continued operation of a cable system on the terms and conditions set forth herein; and

WHEREAS, the Town's Board of Selectmen, as the Franchising Authority, finds that Grantee has complied with the terms of its previous Franchise; and

WHEREAS, insofar as the State of New Hampshire has delegated to the Town the authority to grant a Franchise for cable system operation within the town's territorial boundaries, the Town hereby exercises its authority to grant a non-exclusive Franchise permitting the operation of a cable communications system within the Town.

NOW THEREFORE, after due and full consideration, the Franchising Authority and Grantee agree that this Renewal Franchise is issued upon the following terms and conditions:

#### **DEFINITIONS**

#### **SECTION 1.1 - DEFINITIONS**

For the purpose of this Renewal Franchise, capitalized terms, phrases, words, and abbreviations shall have the meanings ascribed to them in the Cable Communications Policy Act of 1984, as amended from time to time, 47 U.S.C. §§521 et seq. (the "Cable Act"), and the Revised Statutes Annotated of New Hampshire, as amended from time to time, unless otherwise defined herein.

- (a) <u>Basic Cable Service</u> means the lowest tier of service which includes the retransmission of local television broadcast signals.
- (b) <u>Cable Act</u> means the Cable Communications Policy Act of 1984, Public Law No. 98-549, 98 Stat. 2779 (1984), 47 U.S.C. 521 et. seq., amending the Communications Act of 1934, as further amended by the 1992 Cable Consumer Protection and Competition Act, Public Law No. 102-385 and the Telecommunications Act of 1996, Public Law No. 104-458, 110 Stat. 56 (1996) and as may be further amended.
- (c) <u>Cable Television System or Cable System</u> means the facility owned, constructed, installed, operated and maintained by Grantee in the Town of Sunapee, consisting of a set of closed transmission paths and associated signal generation, reception, and control equipment that is designated to provide cable service which includes video programming and which is provided to multiple subscribers within a community, but such term does not include (a) a facility that serves only to retransmit the television signals of one or more television broadcast stations; (b) a facility that serves subscribers without using any public right-of-way; (c) a facility of a common carrier which is subject, in whole or in part, to the provisions of Title II of the Cable Act, except that such facility shall be considered a cable system (other than for purposes of section 621(c) of the Cable Act) to the extent such facility is used in the transmission of video programming directly to

subscribers unless the extent of such use is solely to provide interactive on-demand services; or (d) an open video system that complies with section 653 of this title, or (e) any facilities of any electric utility used solely for operating its electric utility systems.

- (d) <u>Cable Service</u> means the one-way transmission to subscribers of (i) video programming, or (ii) other programming service, and subscriber interaction, if any, which is required for the selection or use of such video programming or other programming service.
- (e) <u>Drop</u> means the coaxial cable that connects a home or building to the Subscriber Network or Video Return Line.
  - (f) <u>Effective Date</u> means April 22, 2008.
- (g) <u>FCC</u> means the Federal Communications Commission or any successor governmental entity.
- (h) <u>Franchise Fee</u> means the payments to be made by the Grantee to the Franchising Authority, the Town of Sunapee and or any other governmental subdivision, such as a PEG Access provider, which shall have the meaning as set forth in Section 622(g) of the Cable Act.
- (i) <u>Franchising Authority</u> means the Board of Selectmen of the Town of Sunapee, New Hampshire, or the lawful designee thereof.
- Grantee from the operation of the Cable System in the Town of Sunapee to provide Cable Services, calculated in accordance with generally accepted accounting principles, including but not limited to monthly Basic Cable Service, premium and pay-per-view fees, installation fees, and equipment rental fees. Gross Annual Revenue shall not include advertising or home shopping revenue, refundable deposits, bad debt, late fees, investment income, nor any taxes, fees or assessments imposed or assessed by any governmental authority and collected by the Grantee on behalf of such entity.
- (k) <u>Grantee</u> means Comcast of Connecticut/Georgia/Massachusetts/New Hampshire/New York/North Carolina/Virginia/Vermont, LLC, or any successor or transferee in accordance with the terms and conditions in this Renewal Franchise.

- (l) <u>Multichannel Video Programming Distributor</u> means a person such as, but not limited to, a cable operator, a multichannel multipoint distribution service, a direct broadcast satellite service, or a television receive-only satellite program distributor, who makes available for purchase, by subscribers or customers, multiple channels of video programming.
- (m) <u>Outlet</u> means an interior receptacle that connects a television set to the Cable Television System.
- (n) <u>Public</u>, <u>Educational and Government (PEG) Access Programming</u> means non-commercial programming produced by any Sunapee residents or organizations, schools and government entities and the use of designated facilities, equipment and/or channels of the Cable System in accordance with 47 U.S.C. 531 and this Renewal License
- (o) <u>Person</u> means any natural person or any association, firm, partnership, joint venture, corporation, or other legally recognized entity, whether for-profit or not-for profit, but shall not mean the Franchising Authority.
- (p) <u>Public</u>, <u>Educational and Governmental Access Channel</u> means a video channel designated for non-commercial use by the public, educational institutions such as public or private schools, but not "home schools," community colleges, and universities, as well as the Franchising Authority.
- (q) <u>Public Way</u> means the surface of, and the space above and below, any public street, highway, freeway, bridge, land path, alley, court, boulevard, sidewalk, way, lane, public way, drive, circle or other public right-of-way, including, but not limited to, public utility easements, dedicated utility strips, or rights-of-way dedicated for compatible uses and any temporary or permanent fixtures or improvements located thereon now or hereafter held by the Franchising Authority in the Town of Sunapee, which shall entitle the Grantee to the use thereof for the purpose of installing, operating, repairing, and maintaining the Cable System. Public Way shall also mean any easement now or hereafter held by the Franchising Authority within the Town of Sunapee for the purpose of public travel, or for utility or public service use dedicated for compatible uses, and shall include other easements or rights-of-way as shall within their proper use

and meaning entitle the Grantee to the use thereof for the purposes of installing, operating, and maintaining the Grantee's Cable System over poles, wires, cables, conductors, ducts, conduits, vaults, manholes, amplifiers, appliances, attachments, and other property as may be ordinarily necessary and pertinent to the Cable System.

- (r) <u>Public Buildings</u> means those buildings owned or leased by the Franchising Authority for government administrative purposes, and shall not include buildings owned by Franchising Authority but leased to third parties or buildings such as storage facilities at which government employees are not regularly stationed.
- (s) <u>Renewal Franchise or Franchise</u> means this Agreement and any amendments or modifications in accordance with the terms herein.
- (t) <u>Standard Installation</u> means the standard one hundred fifty foot (150') Drop connection to the existing distribution system.
- (u) <u>Subscriber</u> means a Person or user of the Cable System who lawfully receives Cable Service with the Grantee's express permission.
- (v) <u>Subscriber Network</u> means the trunk and feeder signal distribution network over which video and audio signals are transmitted to Subscribers.
  - (w) Town means the Town of Sunapee, New Hampshire.
- (x) <u>Video Programming or Programming</u> means the Programming provided by, or generally considered comparable to programming provided by, a television broadcast station.

## **GRANT OF RENEWAL FRANCHISE**

## **SECTION 2.1 - GRANT OF RENEWAL FRANCHISE**

- (a) Pursuant to the authority of RSA 53-C and the Cable Act, the Franchising Authority hereby grants a non-exclusive Renewal Franchise to Comcast of Connecticut/Georgia/Massachusetts/ New Hampshire/New York/North Carolina/Virginia/Vermont, LLC, a Delaware Limited Liability Corporation, authorizing and permitting Grantee to construct, operate and maintain a Cable Television System in the Public Way within the municipal limits of the Town of Sunapee. Nothing in this Franchise shall be construed to prohibit the Grantee from offering any service over its Cable System that is not prohibited by federal or state law.
- (b) This Renewal Franchise is granted under and in compliance with the Cable Act and RSA 53-C of the Laws of New Hampshire, and in compliance with all rules and regulations of the FCC and other applicable rules and regulations in force and effect during the period for which this Renewal Franchise is granted.
- (c) Subject to the terms and conditions herein, the Franchising Authority hereby grants to the Grantee the right to construct, upgrade, install, operate and maintain a Cable Television System within the Public Way.

## **SECTION 2.2 - TERM: NON-EXCLUSIVITY**

The term of this non-exclusive Renewal Franchise shall be for a period of seven (7) years and shall commence on April 22, 2008 and shall expire at midnight on April 21, 2015.

## **SECTION 2.3 – RENEWAL OF FRANCHISE**

The renewal of this Franchise shall be governed by applicable federal law and regulations promulgated thereunder and by applicable New Hampshire law.

## SECTION 2.4 - NON-EXCLUSIVITY OF FRANCHISE [See RSA 53-C:3-b]

- (a) The Grantee acknowledges and agrees that the Franchising Authority reserves the right to grant one or more additional Franchises to other Cable Service providers within the Town for the right to use and occupy the Public Ways or streets within the Franchising Authority's jurisdiction; provided, however, that in accordance with RSA 53-C:3-b(I) no such Franchise agreement shall contain terms or conditions more favorable or less burdensome to the competitive entity than the material terms and conditions herein, including, but not limited to: franchise fees; payment schedules; insurance; system build-out requirements; performance bonds or similar instruments; public, education and government access channels and support; customer service standards; required reports and related record keeping; and notice and opportunity to cure breaches. If any such additional or competitive Franchise is granted by the Franchising Authority which, in the reasonable opinion of the Grantee, contains more favorable or less burdensome terms or conditions than this Renewal Franchise, the Franchising Authority agrees that it shall amend this Renewal Franchise to include any more favorable or less burdensome terms or conditions.
- (b) In the event an application for a new cable television Franchise is filed with the Franchising Authority, proposing to serve the Town, in whole or in part, the Franchising Authority shall serve a copy of such application upon any existing Grantee or incumbent cable operator by registered or certified mail or via nationally recognized overnight courier service within a reasonable time thereafter.
- (c) To the extent allowed by applicable law(s), the grant of any additional cable television Franchise(s) shall be on equivalent terms and conditions as those contained in this Renewal Franchise.
- (d) The issuance of additional Franchise(s) shall be subject to all applicable federal and state laws, including RSA 53-C:3-b and applicable regulations promulgated thereunder.

- (e) In the event that the Grantee believes that any additional Franchise(s) has been granted on terms or conditions more favorable or less burdensome than those contained in this Renewal Franchise, the Franchising Authority shall convene a public hearing on such issue, within not more than thirty (30) days of receipt of a hearing request from the Grantee. Along with said written request, the Grantee shall provide the Franchising Authority with written reasons for its belief. At the public hearing, the Franchising Authority shall afford the Grantee an opportunity to demonstrate that any such additional Franchise(s) are on terms more favorable or less burdensome than those contained in this Renewal Franchise. The Grantee shall provide the Franchising Authority with such financial or other relevant information as is requested.
- (f) Should the Grantee demonstrate that any such additional Franchise(s) have been granted on terms and conditions more favorable or less burdensome than those contained in this Renewal Franchise, the Franchising Authority shall make equitable amendments to this Renewal Franchise within a reasonable time.
- (g) In the event that the Grantee demonstrates that an existing or future Cable Service provider in the Town has been provided relief by the Franchising Authority from any obligation of its Franchise, then the Grantee shall be awarded an equivalent amount of relief from obligations herein. Such relief shall be in writing and in the form of an amendment to this Franchise. The Franchising Authority shall convene a public hearing on the issue within sixty (60) days of Grantee's notification to the Franchising Authority requiring such relief, unless otherwise mutually agreed to. Franchise shall provide reasons for its belief in the notification. At the public hearing, the Franchising Authority shall afford the Grantee an opportunity to demonstrate that any existing or future service providers in the Town have been provided relief by the Franchising Authority from any obligation of its cable television Franchise. The Grantee shall provide the Franchising Authority with such financial or other relevant information as is requested to justify its belief; provided, however, that the parties' counsels mutually and reasonably deem said information is non-proprietary.

- (h) In the event that Cable Services are being provided to the Town by any Person(s) or Multichannel Video Programming Distributor other than the Grantee, which is not in any way an affiliate of the Grantee, and such Person(s)or Multichannel Video Programming Distributor is not required by applicable law to be Franchised by the Franchising Authority, and to the extent that the Grantee reports to the Franchising Authority, in writing, that the providing of such Cable Services by such Person(s) or Multichannel Video Programming Distributor is having a negative financial impact upon the Grantee's Cable System operations in the Town, the Grantee may request, in writing, that the Franchising Authority convene a public hearing on that issue. The Franchising Authority shall convene said hearing within thirty (30) days of receipt of a hearing request from the Grantee.
  - (i) Along with said written request, the Grantee shall provide the Franchising Authority with a written basis and written reasons for its determination of such negative impact. At the public hearing, the Franchising Authority shall afford the Grantee an opportunity to present the basis and the reasons for its determination. The Grantee shall provide the Franchising Authority with such financial and other relevant information as is reasonably requested.
  - (ii) Should the Grantee demonstrate that the Cable Service(s) of such Person(s) is having a negative financial impact upon the Grantee's Cable System operations in the Town, the Franchising Authority shall make equitable amendments to this Renewal Franchise.

#### **SECTION 2.5 - RESERVATION OF AUTHORITY**

Nothing in this Renewal Franchise shall (i) abrogate the right of the Franchising Authority to perform any public works or public improvements of any description, (ii) be construed as a waiver of any codes or bylaws/ordinances of general applicability and not specific to the Cable Television System, the Grantee, or this Franchise, or (iii) be construed as a waiver or release of the

rights of the Franchising Authority in and to the Public Ways. Any conflict between the terms of this Renewal Franchise and any present or future exercise of the municipality's police and regulatory powers shall be resolved by a court of appropriate jurisdiction.

## **SECTION 2.6 - POLE AND CONDUIT ATTACHMENT RIGHTS**

Pursuant to RSA 231:161, permission is hereby granted to the Grantee to attach or otherwise affix including, but not limited to cables, wire, or optical fibers comprising the Cable Television System to the existing poles and conduits on and under public streets and ways, provided the Grantee secures the permission and consent of the public utility companies to affix the cables and/or wires to their pole and conduit facilities. By virtue of this Franchise the Franchising Authority grants Grantee equal standing with power and telephone utilities in the manner of placement of facilities on Public Ways.

## SYSTEM SPECIFICATIONS AND CONSTRUCTION

#### **SECTION 3.1 - AREA TO BE SERVED**

- (a) Grantee shall make Cable Service available to every residential dwelling unit within the Town where the minimum density is at least twenty-five (25) dwelling units per aerial mile and sixty (60) dwelling units per underground mile providing however, that such dwelling units are within one (1) mile of the existing Cable System and the Grantee is able to obtain from property owners any necessary easements and/or permits in accordance with Cable Act. Subject to the density requirement, Grantee shall offer Cable Service to all new homes or previously unserved homes located within one hundred fifty feet (150') of the Grantee's Distribution Cable. For non-Standard Installations the Grantee shall offer said service within ninety (90) days of a Subscriber requesting such for aerial installations and one hundred eighty (180) days, weather permitting, of a Subscriber requesting such for underground installations. With respect to areas of the Town which are currently served by Grantee from a contiguous cable television system or currently unserved but could be served by abutting town(s) served by Grantee, Grantee shall have the option to serve such areas from its cable television system in such abutting town.
- (b) Installation costs shall conform with the Cable Act. Any dwelling unit within one hundred fifty feet (150 ft.) aerial or one hundred fifty feet (150 ft.) underground of the Distribution Cable shall be entitled to a Standard Installation rate, unless the sub-surface is a hard surface or requires boring through rock or a similar hard surface (i.e. concrete, asphalt, etc.). Installations of more than one hundred fifty feet (150 ft.) or which involve a hard surface or which require boring shall be provided at a rate established by the Grantee in accordance with applicable federal and state laws. For installations more than one hundred fifty feet (150 ft.), not involving a hard surface, the first one hundred twenty-five feet (125 ft.) shall be at the Standard Installation rate.

- (c) Provided Grantee has at least ninety (90) days' prior written notice concerning the opening of residential subdivision trenching, or of the installation of conduit for the location of utilities, it shall install its cable in such trenching or conduits or may seek permission to utilize alternative trenching or conduits within a comparable time frame. If a substantial quantity of cable is required for a large subdivision and said quantity is not in stock, the Grantee shall be allowed additional time for said installation. The Franchising Authority, or its designee, shall exercise reasonable efforts to have the Planning Board and developers give timely written notice of trenching and underground construction to the Grantee. Developer shall be responsible for the digging and back-filling of all trenches.
- (d) If all of the transmission and distribution facilities of all of the respective public or municipal utilities, if any, in Town are underground, the Grantee shall place its Cable Systems' transmission and distribution facilities underground; provided that (1) such underground locations are actually capable of accommodating the Grantee's cable and other equipment without technical degradation of the Cable System's signal quality, and (2) the Grantee is reimbursed for its costs associated with such underground placement if reimbursement is made to any of the other respective utility companies in Town. Such reimbursement shall be through payment from the Town. In any area of Town where the transmission or distribution facilities of the respective public or municipal utilities are both aerial and underground, the Grantee shall have the discretion to construct, operate, and maintain all of its transmission and distribution facilities, or any part thereof, aerially or underground. Nothing in this Section shall be construed to require the Grantee to construct, operate, or maintain underground any ground-mounted appurtenances such as customer taps, line extenders, system passive devices, amplifiers, power supplies, pedestals, or other related equipment.
- (f) Grantee shall provide cable service to dwelling units in areas not meeting the above density requirement set forth in subsection 3.1(a), if the requesting customers contribute to the capital cost of construction for extending the line. The cost of contribution by such customers shall be calculated by taking the capital cost of extending such service divided by the number of dwelling

units in such area minus the costs extending service to dwelling units in an area along the Public Ways that meets the twenty-five (25) dwelling units per aerial mile, or sixty (60) dwelling units per underground mile, or fractional proportion thereof as specified in subsection (a) above. The resulting aid in construction cost shall equal the per-dwelling unit contribution relating to line extension of cable service in that particular area of the Town for each unit requesting service, or:

$$C/LE - CA/P = SC$$

- \* C equals the cost of construction of new plant from existing Cable System from the end of the current serviceable line to the last pole necessary to serve the last participating dwelling unit. The costs do not include the installation charges;
- \* LE equals the number of dwelling units requesting service in the line extension area and who subsequently pay a contribution in aid;
- \* CA equals the average cost of construction per mile in the primary service area;
- \* P equals franchise density of twenty-five (25) dwelling units per aerial of aerial plant or sixty(60) dwelling units per underground mile; and
- \* SC equals aid in construction per dwelling unit in the line extension area.
- (g) Each subscriber shall pay his/her proportionate share of the cost of the line extension representing the difference between the number of dwelling units requesting service in the extension area and the average cost of an aerial mile constructed to serve twenty-five (25) homes/linear strand mile. Grantee may require prepayment of the contribution in aid of construction and written commitment for basic cable television service.
- (h) Whenever a prospective subscriber or subscribers located in a line extension area requests a site survey to determine the cost of bringing cable service, Grantee shall, within thirty (30) days of the request, conduct a survey and inform each of the prospective subscribers of the contribution in aid of construction that may be charged. Grantee shall apply for pole attachment agreements within thirty (30) days of its receipt of the contribution in aid of construction from all subscribing dwelling units, and shall make available cable service within ninety (90) days from the receipt by Grantee of the pole attachment agreements and other necessary permits, subject to weather, Force Majeure, and the performance of make ready.

## **SECTION 3.2 - SUBSCRIBER NETWORK**

Grantee shall maintain a Cable Television System, fully capable of carrying a minimum bandwidth of 750MHz.

## SECTION 3.3 - SUBSCRIBER NETWORK CABLE DROPS

- (a) Grantee shall maintain the current level of existing active Drops, Outlets and Basic Cable Service, at no charge to the Town, to each Public Building located along the existing cable route as of the Effective Date, as designated by the Franchising Authority within the Town, listed in **Exhibit A** attached hereto, provided such are considered to be a Standard Installation and absent of other unusual installation conditions and requirements.
- (b) Nothing in this Section shall require Grantee to move existing Drops or Outlets, as listed in **Exhibit A**, or install an additional Drop or Outlet to any municipal or Town owned or leased Public Building which already have a free Drop or Outlet.
- (c) It is understood that Grantee shall not be responsible for any internal wiring of such Public Buildings.

## TECHNOLOGICAL AND SAFETY STANDARDS

#### **SECTION 4.1 - SYSTEM MAINTENANCE**

- (a) In installing, operating and maintaining equipment, cable and wires, the Grantee shall avoid damage and injury to trees, structures and improvements in and along the routes authorized by the Franchising Authority, except as may be approved by the Franchising Authority if required for the proper installation, operation and maintenance of such equipment, cable and wires.
- (b) The construction, maintenance and operation of the Cable Television System for which this Renewal Franchise is granted shall be done in conformance with all applicable laws, bylaws of general applicability, codes and regulations, including but not limited to OSHA, the National Electrical Safety Code, and the rules and regulations of the FCC as the same exist or as same may be hereafter changed or amended.
- (c) Operating and maintenance personnel shall be trained in the use of all safety equipment and the safe operation of vehicles and equipment. Grantee shall install and maintain its equipment, cable and wires in such a manner as shall not interfere with any installations of the Town or any public utility serving the Town.
- (d) All structures and all equipment, cable and wires in, over, under, and upon streets, sidewalks, alleys, and public rights of ways of the Town, wherever situated or located shall at all times be kept and maintained in a safe and suitable condition and in good order and repair.
- (e) The signal of any Broadcast station carried on the Cable Television System shall be carried without material degradation in quality at all subscribing locations within the limits imposed by the technical specifications of the Cable System and as set forth by the FCC. The Cable System shall be operated and maintained so as to comply with the technical standards set forth in the FCC's rules and regulations as they apply to cable television systems.

(f) Upon written notice from the Franchising Authority, the Grantee shall remedy a general deficiency with respect to the technical standards described herein within three (3) months of receipt of notice and a safety deficiency within forty-eight (48) hours of receipt of notice and shall notify the Franchising Authority when the deficiency has been corrected.

## **SECTION 4.2 - REPAIRS AND RESTORATION**

Whenever Grantee takes up or disturbs any pavement, sidewalk or other improvement of any public right of way or public place, the same shall be replaced and the surface restored in as good condition as possible as before entry as soon as practicable. If Grantee fails to make such restoration within a reasonable time, the Franchising Authority may fix a reasonable time for such restoration and repairs, and shall notify Grantee in writing of the restoration and repairs required and the time fixed for the performance thereof. Upon failure of the Grantee to comply within the time specified, the Franchising Authority may cause proper restoration and repairs to be made and the expense of such work shall be paid by Grantee upon written demand by the Franchising Authority. However, prior to such repair or restoration the Town should submit a written estimate to the Grantee of the actual cost of said repair or restoration.

## **SECTION 4.3 - TREE TRIMMING**

Grantee shall have authority to trim trees upon and overhanging public streets, alleys, sidewalks and ways and places of the Town so as to prevent the branches of such trees from coming in contact with the wires, cables and equipment of the Grantee, in accordance with applicable state law and any Town bylaws and regulations.

#### **SECTION 4.4 - BUILDING MOVES**

In accordance with applicable laws, Grantee shall, upon the written request of any person holding a building moving permit issued by the Town, temporarily raise or lower its wires to

permit the moving of the building(s). Grantee shall be given not less than thirty (30) days'

advance written notice to arrange for such temporary wire changes. The cost to raise or lower

wires shall be borne exclusively by the person(s) holding the building move permit.

**SECTION 4.5 - DIG SAFE** 

Grantee shall comply with all applicable "dig safe" provisions, pursuant to RSA 374:51 of

the New Hampshire Laws.

SECTION 4.6 - DISCONNECTION AND RELOCATION

(a) Grantee shall, at its sole cost and expense, protect, support, temporarily disconnect,

relocate in the same street, or other Public Right of Ways, or remove from any street or any other

Public Ways and places, any of its property as required by the Franchising Authority or its

designee by reason of traffic conditions, public safety, street construction, change or establishment

of street grade, or the construction of any public improvement or structure by any Town

department acting in a governmental capacity.

(b) In requiring the Grantee to protect, support, temporarily disconnect, relocate or

remove any portion of its property, the Franchising Authority shall treat Grantee the same as, and

require no more of Grantee, than any other similarly situated utility.

(c) In either case, Grantee shall have the right to seek reimbursement under any

applicable insurance or government program for reimbursement.

SECTION 4.7 – PROHIBITION AGAINST RESELLING OF SERVICE

No Person shall resell, without the express prior written consent of the Grantee, any Cable

Service, program or signal transmitted over the Cable System by Grantee.

## **PROGRAMMING**

## **SECTION 5.1 - BASIC CABLE SERVICE**

Grantee shall make available a Basic Cable Service tier to all subscribers in accordance with 47 U.S.C. 534.

## **SECTION 5.2 - PROGRAMMING**

- (a) Pursuant to 47 U.S.C. 544, Grantee shall maintain the mix, quality and broad categories of Video Programming as set forth in **Exhibit B**. Pursuant to federal law, all Video Programming decisions, excluding PEG Access Programming, are at the sole discretion of the Grantee.
- (b) Grantee shall comply with 76.309(c)(3)(i)(b) of the FCC Rules and Regulations regarding notice of programming changes.

## PEG ACCESS CHANNEL(S) AND SUPPORT

## **SECTION 6.1 - PEG ACCESS CHANNEL**

Use of channel capacity for public, educational and governmental ("PEG") access shall be provided in accordance with federal law, 47 U.S.C. 531, and as further set forth below. Grantee does not relinquish its ownership of or ultimate right of control over a channel by designating it for PEG use. A PEG access user — whether an individual, educational or governmental user — acquires no property or other interest by virtue of the use of a channel so designated, and may not rely on the continued use of a particular channel number, no matter how long the same channel may have been designated for such use. Grantee shall not exercise editorial control over any public, educational, or governmental use of channel capacity, except Grantee may refuse to transmit any public access program or portion of a public access program that contains obscenity, indecency, or nudity pursuant to Section 611 of the Cable Act. The Franchising Authority shall be responsible for developing, implementing, interpreting and enforcing rules for PEG Access Channel use which shall insure that PEG Access Channel(s) and PEG Access equipment will be available on a first-come non-discriminatory basis.

- (a) Pursuant to Section 6.4 and 6.5 below, Grantee shall designate capacity on one (1) channel for a Public Access Channel to be used for public access video programming provided by the Franchising Authority or its designee, such as a public access organization. All expenses associated with said channel are to be supported, administratively and financially, by the Town or its designee. A Public, Educational and Governmental Access Channel may not be used to cablecast programs for profit, political or commercial fundraising in any fashion. Unused capacity may be utilized by Grantee subject to the provisions set forth in subsection (b) below.
- (b) In the event the Franchising Authority or other PEG access user elects not to fully program its Channel, Grantee may reclaim any unused time on the channel.

- (c) Grantee agrees to provide PEG access channel capacity to the Town on a channel other than the Government Access Channel currently cablecast from Newport, New Hampshire, which is currently Channel 10. Grantee further agrees not to reassign the designated Sunapee PEG access channel without advance written notice to the Grantor. In the event that Newport's Government Access Channel is no longer programmed or otherwise is unavailable to the Town of Sunapee, Grantee reserves the right to reclaim said channel.
- (d) On or at any time before the fourth (4<sup>th</sup>) anniversary of the Effective Date, the Franchising Authority may request in writing additional PEG capacity for one (1) additional PEG channel so long as a threshold use requirement is met for the existing PEG access channel designated above. In order to request additional PEG capacity, the existing PEG Access Channels must be programmed continuously with locally produced, non-duplicated, non-character generated, programming for twelve (12) hours per day, six (6) days per week during the available cablecast hours for the previous nine (9) months. The Franchising Authority must also show that there is a need for an additional Access Channel in order to provide additional programming for the benefit of Subscribers during available cablecast hours. For purposes of this Section "available cablecast hours" shall mean the hours between 8:00 am to 10:00 pm.
  - (i) The Franchising Authority must provide Grantee with written, detailed documentation to verify such existing programming, including, but not limited to, program logs that list (i) program titles, (ii) length of program and (iii) whether the program is original first run or repeat.
  - (ii) In the notification to Grantee, the Franchising Authority shall state, in good faith, that such an Access Channel (i) will be substantially programmed with non-duplicated, locally produced, non-character generated programming; and (ii) is necessary to accomplish the stated Access Programming goals of the Town. Such Access Channel will not be used simply to repeat Access Programming that is already carried on the existing Access Channels, but will be used to carry substantially new locally produced Access Programming. The Franchising Authority agrees that such additional Access Channel shall

not be utilized solely to carry character-generated messages; provided, however, that the Town may use said additional Access Channel to carry character-generated messages along with other new locally produced Access Programming.

(iii) Grantee shall make the additional channel available to the Franchising Authority within twelve (12) months of the written notice described above. If channel space is not available, then the parties shall meet to discuss a reasonable timetable for making such additional Access Channel available to the Franchising Authority, said timetable not to exceed twenty four (24) months from the date of the written notice from the Franchising Authority. Grantee reserves the right to reclaim any unused Access Channel.

## SECTION 6.2 – PEG ACCESS PROVIDER

The Grantee shall not be responsible for the provision of PEG Access Programming. Franchising Authority may identify a PEG Access Provider whose responsibility shall be to provide services to PEG Access Users and the Town. The designated access provider or Franchising Authority shall provide services to PEG Access Users and the Town as follows:

- (1) Schedule, operate and program the PEG Access channels provided in accordance with Section 6.1 above;
- (2) Manage the funding, pursuant to Section 9.4(a) herein;
- (3) Purchase, maintain and/or lease equipment, with the funds allocated for such purposes in Section 9.4(a) herein;
- (4) Conduct training programs in the skills necessary to produce PEG Access Programming;
- (5) Provide technical assistance and production services to PEG Access users;
- (6) Establish rules, procedures and guidelines for use of the PEG Access Channels;
- (7) Provide publicity, fundraising, outreach, referral and other support services to PEG Access users;

- (8) Assist users in the production of Video Programming of interest to Subscribers and issues, events and activities; and
- (9) Accomplish such other tasks relating to the operation, scheduling and/or management of the PEG Access Channel, facilities and equipment as appropriate and necessary.

## SECTION 6.3 - PROGRAMMING EXCLUSIVITY AND NON-COMPETITION

The Franchising Authority, or its designee, agrees that it will not use its designated PEG Access channels, equipment, or other facilities to provide for-profit commercial services which have the effect of competing with the Grantee's business. In addition, any Video Programming produced under the provisions of this Article 6 shall not be commercially distributed to a competing Multichannel Video Programming Distributor without the written consent of the Grantee.

## **SECTION 6.4 – VIDEO RETURN LINE**

- (a) Grantee shall continue to provide and maintain the existing video return line to be utilized by the Franchising Authority or its designee, including a PEG Access provider. Said video return line shall be capable of transmitting composite video and audio transmissions from the Town Office located at 23 Edgemont Road in Sunapee and returned over the Grantee-owned Subscriber Network.
- (b) In the event the Franchising Authority identifies a new municipal or public building to be connected for a video return line to originate and support the second channel provided pursuant to Section 6.1(d) above, the Franchising Authority shall pay Grantee for all costs of construction of said video return line including a reasonable return on investment. Grantee shall discuss the location of each Outlet with the appropriate officials in the building, prior to the installation of such Outlet. The Franchising Authority shall designate such officials in writing to Grantee.

- (c) The video return line(s) shall be interconnected with the Subscriber Network at Grantee-owned Headend or Hub site. All remote video return line signals to be interconnected to a Downstream Access Channel shall be sent on an Upstream Channel to the Grantee-owned Headend or hub site.
- (d) Grantee shall continue to have the sole responsibility for maintaining the video return line(s) for the term of this Franchise, except for equipment not directly under its control or ownership. Grantee shall be responsible for all necessary inspections and performance tests of the video return line(s) in accordance with 47 CFR §76.601.

## **SECTION 6.5 - PEG ACCESS CABLECASTING**

- (a) In order that PEG Access Programming can be cablecast over Grantee's downstream PEG Access Channel, all PEG Access Programming shall be modulated, then transmitted from the Town Office located at 23 Edgemont Road in Sunapee to the Grantee-owned headend or hub-site on the Grantee-owned video return line made available, without charge, to the Town for its use. At the Grantee-owned head-end, said PEG Access Programming shall be retransmitted in the downstream direction on one Grantee-owned Subscriber Network downstream PEG Access Channel.
- (b) Grantee shall provide and maintain all necessary switching and/or processing equipment located at its hub-site or headend in order to switch upstream signals carrying PEG Access Programming from the Town Office located at 23 Edgemont Road in Sunapee to the designated Grantee-owned Subscriber Network downstream PEG Access Channel.
- (c) Grantee shall own, maintain, repair and/or replace any Grantee-owned headend or hub-site audio or video signal processing equipment. The Town and/or PEG access provider shall own, maintain, repair and/or replace studio or portable modulators and demodulators. The demarcation point between the Grantee's equipment and the Town's or PEG Access provider's equipment shall be at the output of the Town's and/or the PEG Access provider's modulator(s) at the Town Office at 23 Edgemont Road.

#### CUSTOMER SERVICE AND CONSUMER PROTECTION

#### **SECTION 7.1 - CUSTOMER SERVICE**

Grantee shall comply with all customer service regulations of the FCC (47 CFR §76.309) as they exist or as they may be amended from time to time.

## **SECTION 7.2 - SERVICE INTERRUPTIONS**

In the event that the Grantee's service to any Subscriber is completely interrupted for twenty-four (24) or more consecutive hours, the Grantee will grant such Subscriber a pro rata credit or rebate upon request, on a daily basis, of that portion of the service charge during the next consecutive billing cycle, or at its option, apply such credit to any outstanding balance then currently due. In the instance of other individual Subscriber service interruptions, credits shall be applied as described above after due notice to the Grantee from the Subscriber.

#### SECTION 7.3 - PROTECTION OF SUBSCRIBER PRIVACY

Grantee shall comply with all applicable federal and state privacy laws and regulations, including 47 U.S.C. 551 and regulations adopted pursuant thereto.

## **SECTION 7.4 – PROPRIETARY INFORMATION**

Notwithstanding anything to the contrary set forth in this Franchise, the Grantee shall not be required to disclose information which it reasonably deems to be proprietary or confidential in nature. The Franchising Authority agrees to treat any information disclosed by the Grantee as confidential and only to disclose it to those employees, representatives, and agents of the Franchising Authority that have a need to know in order to enforce this Franchise and who shall agree to maintain the confidentiality of all such information. Grantee shall not be required to

provide Subscriber information in violation of 47 U.S.C. 551 or any other applicable federal or state privacy law. For purposes of this Section, the terms "proprietary or confidential" include, but are not limited to, information relating to the Cable System design, customer lists, marketing plans, financial information unrelated to the calculation of franchise fees or rates pursuant to FCC rules, or other information that is reasonably determined by the Grantee to be competitively sensitive. In the event that the Franchising Authority receives a request under a state "sunshine," public records or similar law for the disclosure of information the Grantee has designated as confidential, trade secret or proprietary, the Franchising Authority shall notify Grantee of such request and cooperate with Grantee in opposing such request.

## **SECTION 7.5 - EMPLOYEE IDENTIFICATION CARDS**

All of the Grantee's employees, including repair and sales personnel, entering private property shall be required to carry an employee identification card issued by the Grantee.

## PRICES AND CHARGES

## **SECTION 8.1 - PRICES AND CHARGES**

All rates, fees, charges, deposits and associated terms and conditions to be imposed by the Grantee or any affiliated Person for any Cable Service as of the Effective Date shall be in accordance with applicable FCC's rate regulations [47 U.S.C. 543]. Before any new or modified rate, fee, or charge is imposed, the Grantee shall follow the applicable FCC and State notice requirements and rules and notify affected Subscribers, which notice may be by any means permitted under applicable law. Nothing in this Renewal Franchise shall be construed to prohibit the reduction or waiver of charges in conjunction with promotional campaigns for the purpose of attracting or retaining Subscribers.

#### REGULATORY OVERSIGHT

## **SECTION 9.1 - INDEMNIFICATION**

Grantee shall indemnify, defend and hold harmless the Franchising Authority, its officers, employees, and agents from and against any liability or claims resulting from property damage or bodily injury (including accidental death) that arise out of the Grantee's construction, operation, maintenance or removal of the Cable System, including, but not limited to, reasonable attorney's fees and costs, provided that the Franchising Authority shall give the Grantee written notice of its obligation to indemnify and defend the Franchising Authority within ten (10) business days of receipt of a claim or action pursuant to this Section. If the Franchising Authority determines that it is necessary for it to employ separate counsel, the costs for such separate counsel shall be the responsibility of the Franchising Authority.

#### **SECTION 9.2 - INSURANCE**

(a) Grantee shall carry insurance throughout the term of this Renewal Franchise and any removal period with an insurance company authorized to conduct business in New Hampshire satisfactory to the Franchising Authority protecting, as required in this Renewal Franchise, the Grantee and listing the Town as an additional insured, against any and all claims for injury or damage to persons or property, both real and personal, caused by the construction, installation, operation, maintenance or removal of its Cable System. The amount of such insurance against liability for damage to property shall be no less than One Million Dollars (\$1,000,000) as to any one occurrence. The amount of such insurance for liability for injury or death to any person shall be no less than One Million Dollars (\$1,000,000). The amount of such insurance for excess liability shall be Five Million Dollars (\$5,000,000) in umbrella form. Policy will contain a

provision that the Franchising Authority will receive thirty (30) days' written notice prior to any cancellation.

- (b) Grantee shall carry insurance against all claims arising out of the operation of motor vehicles and general tort or contract liability in the amount of One Million Dollars (\$1,000,000). Policy will contain a provision that the Franchising Authority will receive thirty (30) days' written notice prior to any cancellation.
- (c) All insurance coverage, including Workers' Compensation, shall be maintained throughout the period of this Renewal Franchise. All expenses incurred for said insurance shall be at the sole expense of the Grantee. Policy will contain a provision that the Franchising Authority will receive thirty (30) days' written notice prior to any cancellation.
- (d) The Grantee shall provide Franchising Authority with certificate(s) of insurance for all policies required herein upon expiration of policies.

#### **SECTION 9.3 - PERFORMANCE BOND**

- (a) Grantee has submitted and shall maintain throughout the duration of this Renewal Franchise and any removal period a performance bond in the amount of Twenty-five Thousand Dollars (\$25,000) running to the Town with a surety company satisfactory to the Franchising Authority to guarantee the following terms:
  - (1) the satisfactory completion of the installation and operation of the Cable System in the time schedule provided herein; (2) the satisfactory restoration of pavements, sidewalks and other improvements;
  - (3) the indemnity of the Town; and
  - (4) the satisfactory removal or other disposition of the Cable System.
- (b) Grantee shall not reduce the amount or cancel said bond, or materially change the terms of said bond from the provisions of Section 9.3(a) herein without the Franchising

Authority's prior written consent. The Franchising Authority shall not unreasonably withhold its consent.

## **SECTION 9.4 – FRANCHISE FEES**

- (a) Upon three (3) months advance written notice by the Franchising Authority to Grantee, and subject to the Franchising Authority holding a public hearing on the issue, Grantee shall begin to collect a Franchise Fee from subscribers with the intent of making an annual payment to the Franchising Authority. Such annual payment shall be no more than five percent (5%) of Grantee's Gross Annual Revenues. Said annual payments shall be made on February 15<sup>th</sup> of each year of the term of this Renewal Franchise based on revenues received during the prior calendar year. The first payment shall be prorated to reflect the time period for which this provision was triggered and in effect. The last payment shall be prorated to reflect the time period for which the Franchise was in effect.
- (b) In accordance with Section 622(b) of the Cable Act, Grantee shall not be liable for a total financial commitment pursuant to this Renewal Franchise and applicable law in excess of five percent (5%) of its Gross Annual Revenues; provided, however, that said five percent (5%) shall also include any amounts included in the term "Franchise Fee" pursuant to Section 622(g)(1) of the Cable Act, but shall not include (i) interest due herein to the Franchising Authority because of late payments; and (ii) any other exclusion to the term "Franchise Fee" pursuant to Section 622(g)(2) of the Cable Act. Any funds required to be paid by the Grantee to the Franchising Authority, its designee or the Town to support PEG Access Programming, equipment and/or facilities shall be considered part of, and not in addition to, the Franchise Fee described in Section 9.4(a).
- (c) All payments by the Grantee to the Town pursuant to this Section shall be made payable to the Town and deposited with the Town Treasurer unless otherwise agreed to in writing by the parties.

(d) Grantee reserves its rights to pass through any and all eligible franchise related costs to subscribers, including franchise fees.

#### **SECTION 9.5 - REPORTS**

Grantee shall maintain for public inspection all records required by the FCC and as specified in 47 CFR §76.305 in the manner prescribed therein.

## **SECTION 9.6 - EQUAL EMPLOYMENT OPPORTUNITY**

Grantee is an Equal Opportunity Employer and shall comply with applicable FCC regulations with respect to Equal Employment Opportunities.

## **SECTION 9.7 - REVOCATION OF FRANCHISE**

Upon written notice, the Franchise issued hereunder may, after due process, opportunity to cure and public hearing held by the Franchising Authority pursuant to Section 9.8 herein, and subject to any other rights available to the Grantee, be revoked by the Franchising Authority for any of the following reasons:

- (a) For failure to file and maintain the performance bond as described in Section 9.3 (Performance Bond) or to maintain insurance as described in Section 9.2 (Insurance);
- (b) For repeated failure to maintain signal quality pursuant to the standards provided for by the FCC;
- (c) For any transfer or assignment of the Renewal Franchise without prior notice to the Franchising Authority in violation of Section 9.9 herein; and
  - (d) For repeated failure to comply with the material terms and conditions.

## SECTION 9.8 - NOTICE AND OPPORTUNITY TO CURE

In the event that the Franchising Authority has reason to believe that the Grantee has defaulted in the performance of any or several provisions of this Renewal Franchise, except as excused by Force Majeure, the Franchising Authority shall notify the Grantee in writing, by certified mail, of the provision or provisions which the Franchising Authority believes may have been in default and the details relating thereto. The Grantee shall have ninety (90) days from the receipt of such notice to:

- (a) Respond to the Franchising Authority in writing, contesting the Franchising Authority's assertion of default and providing such information or documentation as may be necessary to support the Grantee's position; or
- (b) Cure any such default (and provide written evidence of the same), or, in the event that by nature of the default, such default cannot be cured within such ninety (90) day period, to take reasonable steps to cure said default and diligently continue such efforts until said default is cured. The Grantee shall report to the Franchising Authority, in writing, by certified mail, at forty-five (45) day intervals as to the Grantee's efforts, indicating the steps taken by the Grantee to cure said default and reporting the Grantee's progress until such default is cured.
- (c) In the event that (i) the Grantee fails to respond to such notice of default; and/or (ii) the Grantee fails to cure the default or to take reasonable steps to cure the default within the required ninety (90) day period; the Franchising Authority or its designee shall promptly schedule a public hearing no sooner than fourteen (14) days after written notice, by certified mail, to the Grantee. The Grantee shall be provided reasonable opportunity to offer evidence, question witnesses, if any, and be heard at such public hearing.
- (d) Within thirty (30) days after said public hearing, the Franchising Authority shall issue a written determination of its findings. In the event that the Franchising Authority determines that the Grantee is in such default, the Franchising Authority may determine to pursue any lawful remedy available to it.

(e) In the event that (i) the Franchising Authority fails to issue a written reply within 30 days accepting or rejecting Grantees' response pursuant to 9.8(a) above; (ii) the Franchising Authority fails to issue a written acknowledgement after Grantee's notice that it cured said default pursuant to 9.8(b) above; and/or (iii) the Franchising Authority fails to schedule a public hearing no later than thirty (30) days of having sent a written notice consistent with Section 9.8(c) above and/or (iv) the Franchising authority fails to issue a written determination with thirty (30) days after the public hearing pursuant to Section 9.8(d) above, then the issue of said default against the Grantee by the Franchising Authority shall be considered null and void.

## **SECTION 9.9 - TRANSFER OR ASSIGNMENT**

This Renewal Franchise shall not be transferred or assigned without the prior written consent of the Franchising Authority, which consent shall not be arbitrarily or unreasonably withheld. No consent shall be required, however, for (i) a transfer in trust, by mortgage, hypothecation, or by assignment of any rights, title, or interest of the Grantee in the Franchise or in the Cable System in order to secure indebtedness, or (ii) a transfer to an entity directly or indirectly owned or controlled by Comeast Corporation. The application for consent to an assignment or transfer shall be signed by the Grantee and by the proposed assignee or transferee or by their representatives, evidence of whose authority shall be submitted with the application. Within thirty (30) days of receiving a request for consent, the Franchising Authority shall, in accordance with FCC rules and regulations, notify the Grantee in writing of the additional information, if any, it requires determining the legal, financial, and technical qualifications of the transferee or new controlling party. If the Franchising Authority has not taken action on the Grantee's request for consent within one hundred twenty (120) days after receiving such request, consent shall be deemed given.

## **SECTION 9.10 - INCORPORATION BY REFERENCE**

(a) All presently and hereafter applicable conditions and requirements of federal, state and local laws, including but not limited to the rules and regulations of the FCC and the State of New Hampshire, as they may be amended from time to time, are incorporated herein by reference, to the extent not enumerated herein. All such general laws, rules, and regulations, as amended, shall control the interpretation and performance of this Renewal Franchise to the extent that any provision of this Renewal Franchise conflicts with or is inconsistent with such laws, rules or regulations.

(b) Should the State of New Hampshire, the federal government or the FCC require the Grantee to perform or refrain from performing any act the performance or non-performance of which is inconsistent with any provisions herein, the Franchising Authority and the Grantee will thereupon, if they determine that a material provision herein is affected, modify any of the provisions herein to reflect such government action.

#### **MISCELLANEOUS**

## **SECTION 10.1 - SEVERABILITY**

If any section, subsection, sentence, clause, phrase, or other portion of this Renewal Franchise is, for any reason, declared invalid, in whole or in part, by any court, agency, commission, legislative body, or other authority of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent portion. Such declaration shall not affect the validity of the remaining portions hereof, which other portions shall continue in full force and effect.

## **SECTION 10.2 - FORCE MAJEURE**

If for any reason of force majeure the Grantee is unable in whole or in part to carry out its obligations hereunder, said Grantee shall not be deemed in violation or default during the continuance of such inability. Unless further limited elsewhere in this Franchise, the term "force majeure" as used herein shall have the following meaning: strikes; acts of god; acts of public enemies, orders of any kind of the government of the United States of America or of the State of New Hampshire or any of their departments, agencies, political subdivisions, or officials, or any civil or military authority; insurrections; riots, epidemics; landslides; lightning; earthquakes; tornados; fires; hurricanes; volcanic activity; storms; floods; washouts; droughts, arrests; civil disturbances; explosions; partial or entire failure of utilities; unavailability of materials and/or essential equipment, environmental restrictions or any other cause or event not reasonably within the Grantee's control.

#### **SECTION 10.3 - NOTICES**

(a) Every notice to be served upon the Franchising Authority shall be delivered or sent by certified mail (postage prepaid) to the following address or such other address as the Franchising Authority may specify in writing to the Grantee.

(c) Delivery of such notices shall be equivalent to direct personal notice, direction or order, and shall be deemed to have been given at the time of receipt.

## **SECTION 10.4 - ENTIRE AGREEMENT**

This instrument contains the entire agreement between the parties, supersedes all prior agreements or proposals except as specifically incorporated herein, and cannot be changed without written amendment following publication of the proposed amendment in a manner consistent with the publication and notice provisions of RSA Chapter 43.

## **SECTION 10.5 - CAPTIONS**

The captions to sections throughout this Renewal Franchise are intended solely to facilitate reading and reference to the sections and provisions of the Renewal Franchise. Such sections shall not affect the meaning or interpretation of the Renewal Franchise.

## SECTION 10.6 - APPLICABILITY OF RENEWAL FRANCHISE

All of the provisions in this Renewal Franchise shall apply to the Town, the Grantee, and their respective successors and assigns.
